



## **Announcement of Khun Kaew Subdistrict Municipality**

### **regarding No Gift Policy measures**

According to the Organic Act on Prevention and Suppression of Corruption, B.E. 2020, Section 128, paragraph one, no government official is prohibited from receiving property or any other benefit that may be calculated as Income from anyone other than assets or benefits that should be obtained according to law Rules or regulations issued by virtue of Power according to the provisions of the law Except for receiving property or any other benefits through ethics according to the criteria and amounts specified by the NACC and according to the Cabinet resolution on December 4, 2020, which approved the national reform plan for preventing and suppressing corruption and misconduct. like (revised edition) by specifying that there will be a drive To carry out important reform activities (Big Rock) Reform activity number 4: Develop the Thai bureaucratic system to be transparent. Useless The third goal, Section 1.1, is for all agencies to declare themselves as All government officials do not accept gifts and gratuities of any kind. from performing duties (No Gift Policy)" In addition, the Khun Kaew Subdistrict Municipality has also announced its intention to administer with honesty as a measure to develop the agency for its officials. Has been followed along with other rules, regulations and regulations. and to drive reform activities according to the national reform plan above. Create transparency within the agency Create values in performing duties and should practice it as an honest culture of Khun Kaew Subdistrict Municipality

Therefore, in order to strengthen the culture honest values and avoid actions that affect discretion or decision-making in the performance of duties, which may lead to discrimination or cause conflicts of interest. Khun Kaew Subdistrict Municipality has therefore established a policy for all executives and government officials in the unit The event will not accept gifts and favors. All types before/while/after performing duties that will result in corruption and misconduct both now and in the future" by allowing the executive team municipal council member Municipal employees, regular employees, and employees hired under the agency Khun Kaew Subdistrict Municipality Adhere to the guidelines as follows:

(1) Refrain from receiving or giving gifts and presents of all kinds. or any other benefits from performing duties or in exchange for performing duties

/(2) Must not..

~~(2) Must not ask or seek to obtain gifts. All kinds of gifts or any other benefits that is legal~~

(3) Not consenting or conniving with family members to give or receive gifts. All kinds of gifts or any other benefits with those involved in the operation

(4) There is no conflict of interest in the performance of work, as well as providing benefits to oneself or one's own group which causes damage to the government or through dishonesty

(5) In the case where government officials under the Khun Kaew Subdistrict Municipality are found to have committed such crimes, the Khun Kaew Subdistrict Municipality will seriously punish them.

However, except in cases of unavoidable necessity, the rules for accepting gifts or gifts must be followed, and any other benefits in accordance with the regulations of the Office of the Prime Minister regarding the giving or receiving of gifts by Rak officials B.E. 2001, together with the announcement of the National Anti-Corruption Commission on the criteria for accepting gifts. Property or any other benefits according to the ethics of government officials, B.E. 2020
